Dual system for granting foreign nationals access to the Swiss labour market:

- ***EU/EFTA nationals***: Agreement on the Free Movement of Persons (AFMP);
- ***Non-EU/EFTA nationals***: restrictive conditions (Federal Act on Foreign Nationals).

*Nationality is key* (a non-European citizen with a valid permit in an EU/EFTA country is considered as such when he/she is hired by an employer in Geneva).

## **Romania – Bulgaria**

Since June 1st 2016, Bulgarian and Romanian workers are subject to the same system as citizens of the EU-25/EFTA.

## **United Kingdom**

The United Kingdom is still a member of the EU; the Brexit has no legal consequence so far.

## **Croatia**

Member of the EU, but does not yet benefit from the AFMP. Restrictive conditions apply.

# Nationals of the EU-27/EFTA countries

## (work contract with an NGO in Geneva)

**Upon arrival of the employee, the employer must send the following documents to the OCPM:**

- M or F form **fully** completed, dated and signed;
- Copy of the employee's passport or identity card;
- 2 photos (passport size).

**If residing in Switzerland:**

- Copy of a marriage certificate for spouse;
- Copy of birth certificate for each child;
- Copy of the rental lease or equivalent document.

# Types of work permits EU-27/EFTA

## Online notification

*For employment up to 90 days per calendar year.*

## L permit

*For employment for a limited period of time (from 3 months up to 12 months) reflecting the period specified in the employment contract.*

## B permit

*Long term work permit for five years (more than 12 months).*

## G permit

*For employment for a limited period of time (from 3 months up to 12 months) reflecting the period specified in the employment contract.  
More than 12 months the employee will receive a permis G for five years.*

# Non-EU/EFTA nationals

## (work contract with an NGO in Geneva)

- The NGO sends all necessary documents to the OCPM who will send the file to the MOE (OCIRT).
- The request must be filed *6-8 weeks in advance*.
- The foreign national must wait abroad while the process is being completed. It includes the approval of the cantonal decision by the federal authority.
- At the end of the process, the foreign worker must get a visa at the closest Swiss embassy in order to legally enter Switzerland.
- An internship (unpaid or paid) requires a work authorization.

# Non-EU/EFTA nationals

## (work contract with an NGO in Geneva)

### **Necessary documents :**

- M form **fully** completed, dated and signed ;
- Copy of the employee's passport;
- Cover letter explaining why the NGO needs to hire this particular person (project, job description, etc.) ;
- Employee's CV + copies of diplomas ;
- Signed employment contract ;
- Detailed information on the hiring process and the need to hire an non-European national (non-applicable if intra-group transfer of an executive or a specialist).

# Non-EU/EFTA nationals (work contract with an NGO in Geneva)

## **Necessary documents for cross-border commuters :**

- F form **fully** completed, dated and signed ( $\neq$  M form) ;
- Copy of a valid residence permit in France ;
- Proof of residence in the border area for more than 6 months ;
- 2 photos (passport size) ;
- Other documents: same as above.

# Non-EU/EFTA nationals

## (work contract with an NGO in Geneva)

### ***Applicable legal criteria:***

- Economic interest (for NGOs importance for the "international Geneva");
- High level of qualifications and responsibilities;
- Third state nationals may only be admitted if nobody can be recruited in the labour market of Switzerland or EU/EFTA countries. Vacant positions must be registered with the cantonal employment office; other channels of recruitment must be used (employment agencies, online job listings, etc.) The NGO must provide detailed information on the recruitment process and its results;

# Non-EU/EFTA nationals (work contract with an NGO in Geneva)

## ***Applicable legal criteria:***

- The salary and work conditions are examined;  
(no part-time jobs!)
- Availability of quotas (> 4 months contracts).
- Internships (persons studying abroad): can be authorized; however, given the limited number of work permits available, internships must be limited to 4 months.  
We do not convert permits granted for an internship into regular or long term permits.

# Types of work permits for non-Europeans

## **L permit**

Short stay work permit (4 to 24 months maximum)

Linked to contract and employer

Quota: 133 L permits per year for the canton of Geneva

Family reunification can be authorized

## **B permit**

Long term work permit

Additional restrictions can be applied (e.g. to professional mobility)

Quota: 83 B permits per year for the canton of Geneva

Family reunification can be authorized

## **G permit**

For cross-border commuters; no quota, no federal approval.
